^Note: Please note that pursuant to the order of Hon'ble National Company Law Tribunal, Chandigarh Bench (**``NCLT''**) dated June 11, 2024 on the Composite Scheme of Amalgamation and Arrangement among erstwhile GMR Airports Limited (hereinafter referred to as **``Transferor Company 1''**), erstwhile GMR Infra Developers Limited (hereinafter referred to as **``Transferor Company 2''**) and the Company (hereinafter referred to as **``Transferee Company/Company''**) and their respective shareholders and creditors (hereinafter referred to as **``Scheme''**), Transferor Company 1 and Transferor Company 2 stand merged with Transferee Company with effect from July 25, 2024. Pursuant to the said scheme, Non-Convertible Bonds (**``NCBs''**) amounting to Rs. 5,000 Crore issued by Transferor Company 1 were transferred to the Company under new ISINs (as mentioned above) and the application for listing of Rs. 5,000 Crore NCBs were made by the Company.

***Note:** The ISIN for the aforesaid issue was allotted in the month of March, 2025 however, the securities were listed in the month of April, 2025 i.e post the closure of financial year 2024-25.
