The US intelligence community in its report concluded that SARS-CoV-2, the virus that causes Covid-19, was 'not developed' as a biological weapon, with President Joe Biden reiterating that China continues to reject calls for transparency and withhold information about the origins of the virus. Critical information about the origins of this pandemic exists in China, "yet from the beginning, government officials in China have worked to prevent international investigators and members of the global public health community from accessing it,"Biden said after acknowledging the receipt of the report. The Director of the US National Intelligence in the report said that Covid-19 probably emerged and infected

humans through an initial small-scale exposure that occurred no later than November 2019 with the first known cluster of Covid-19 cases arising in Wuhan, China in December 2019. There was no unanimity among the intelligence community(IC) on the origins of the coronavirus and the intelligence community was split on whether it leaked from a lab in China or emerged in nature.

Despite criticism in the report of China's reluctance to provide key information and blocking a probe, the report is regarded here as a major relief for China as it has failed to pin the blame on Beijing and was much on the same lines as the first probe conducted by WHO experts.




