# **Key Developments**

# Steady progress on creation of "GAL Platform" to foray into Airport adjacency businesses

- Delhi Duty Free: Process of takeover completed in Jul'25 and GAL started operating duty free business from 28 Jul'25
- Delhi Cargo City: Received a Letter of Intent to Award (LOIA)<sup>4</sup> from Delhi International Airport Limited (DIAL) and subsequently signed the concession to finance, design, develop, construct, operate, manage and maintain the Cargo City at the Indira Gandhi International Airport (IGI) over a total of 50.5 acres land within IGI. The concession period is up to 2036, extendable by another 30 years. Revenue share to DIAL over the initial concession period based on minimum guarantee is estimated to be ~INR 416 Crs
- o **Hyderabad Duty Free:** Process of takeover completed. GAL started operating from 10 Sep'25

## Refinancing Activities

- GAL: Raised<sup>5</sup> INR 59bn in form of Non-Convertible Bonds (NCB) and used the proceeds to refinance debt. Tranche 1 of INR 15bn carries tenure of 18 months and coupon rate of 5.0% p.a with redemption premium of 5.225% p.a. while Tranche 2 of INR 44bn carries tenure of 36 months and coupon rate of 5.0% p.a with redemption premium of 5.425% p.a
- o **DIAL:** Raised<sup>6</sup> INR 10bn in form of Non-Convertible Debentures (NCD) for a period of 15 years at coupon rate of 8.75% and used the proceeds to refinance debt bearing 9.98% coupon rate



**Delhi Airport (DIAL)** 



## Traffic Insight

**Q2FY26:** Pax traffic at 17.6mn, down by 7.5% YoY from 19.0mn in Q2FY25 attributable to temporary disruptions in flight operations caused by changed airspace conditions amid geopolitical events and Runway 10/28 upgradation at Delhi Airport

Domestic traffic decreased by 8.9% while International traffic decreased by 3.9% YoY

H1FY26: Pax traffic at 36.7mn, down by 4.3% YoY from 38.3mn in H1FY25

Domestic traffic decreased by 5.8% while International traffic was almost unchanged YoY

## Key Financials

### **Total Income**

- Q2FY26: Increased to INR 1,849 Crs, up by 34% YoY from INR 1,379 Crs in Q2FY25 driven by aero revenues which rose 166% YoY post implementation of revised tariffs
- H1FY26: Increased to INR 3,615 Crs, up by 36% YoY from INR 2,667 Crs in H1FY25

### **EBITDA**

- Q2FY26: Increased to INR 675 Crs, up by 69.4% YoY from INR 398 Crs in Q2FY25. Quarterly EBITDA was the highest in last 4 years

Domestic traffic increased by 3.5% while International traffic increased by 15.0% YoY

H1FY26: Pax traffic at 15.4mn, up by 11.3% YoY from 13.8mn in H1FY25

Domestic and International traffic increased by 11% YoY

## Traffic Insight

Q2FY26: Pax traffic at 1.13mn, up by 9.0% YoY from 1.04mn in Q2FY25

- Domestic traffic increased by 8.5% while International traffic increased by 18.4% YoY
- Captured ~46% market share (of Goa system traffic) in Q2FY26

H1FY26: Pax traffic at 2.36mn, up by 8.1% YoY from 2.18mn in H1FY25

Domestic traffic increased by 6.0% while International traffic increased by 65.3% YoY

# **Total Income**

- Q2FY26: Decreased to INR 84 Crs, down by 14.5% YoY from INR 98 Crs in Q2FY25 as Aero Revenues decreased 26.7% YoY as it includes impact of special initiative program to attract airlines. Non Aero Revenues increased by 19.2% YoY
- o H1FY26: Decreased to INR 186 Crs, down by 3.4% YoY from INR 192 Crs in H1FY25

Q2FY26: Pax traffic at 1.77mn, down by 3.4% YoY from 1.84mn in Q2FY25

- Domestic traffic decreased by 6.7% while International traffic increased by 3.9% YoY
- Domestic pax growth continues to be impacted by delay in reactivation of fleets by airlines

H1FY26: Pax traffic at 3.54mn, unchanged vs. H1FY25
